

**INTERNATIONAL COOPERATION AGREEMENT
BETWEEN
KAZAKH-RUSSIAN INTERNATIONAL UNIVERSITY
AND
NATIONAL UNIVERSITY-SUDAN**

“30” January 2014

Kazakh-Russian International University (further KRIU) in the person of Temerkhan Baibosynovich Berdimuratov, President of KRIU acting on the basis of Charter on the one Part, and, NATIONAL UNIVERSITY-SUDAN (further NU-S) (Khartoum- Sudab) in the person of Qurashi M. Ali, Vice Chancellor, on the other Part, hereinafter named “Parties” have concluded the Present Agreement as follows:

1. Subject of the Agreement

- 1.1. The subject of the Present Agreement is cooperation between the Parties in the field of academic-methodological, scientific-research, consulting and organizational work.

2. The area of cooperation

- 2.1. Mutual promotion in international academic mobility of undergraduate, graduate students, faculty, research and administrative staff of universities-partners for studying, teaching, conducting research and training.
- 2.2. Development and implementation of the joint research works and projects (fundamental, applied research and scientific-technical development).
- 2.3. Creating joint teams for compiling textbooks, manuals, and methodological recommendations and conducting research.
- 2.4. Joint designing and development of educational and research laboratories.
- 2.5. Organizing and conducting joint research and practice conferences, symposiums, forums, congresses, training seminars, workshops, lectures, study trips, scientific training and different types of internship, scientific consulting on educational programs of universities.
- 2.6. Organizing joint courses on advanced training and retraining of faculty.
- 2.7. Publication of scientific articles in journals with high level of impact factor recommended by agency TR (Thomson Reuters).
- 2.8. Organizing and conducting courses of recognized professors and scientists.
- 2.9. Exchange of information, scientific publications and other research and didactic materials.

3. Rights and obligations of the Parties

The Parties are obliged to:

- 3.1. To provide required information for organizing and improving the work in the framework of the Present Agreement.
- 3.2. To ensure proper performance of the Present Agreement.
- 3.3. To strain after purposeful support from the institutions of regions of both Parties.

The Parties have the rights:

- 3.4. In the framework of the Present Agreement to conclude separate agreements on certain projects with indication of content, deadlines and volumes in different fields of cooperation.
- 3.5. To define representatives authorized for coordination of current problems of cooperation. Heads of separate projects are appointed on mutual agreement.

3.6. On all issues concerning the Present Agreement KRIU will conduct negotiations with Professor Qurashi M. Ali.

4. Agreement duration

4.1. The Present Agreement will be effective from the date of signing and shall remain in force for a period of five (5) years with further prolongation, in case neither Party initiates the termination of the Agreement.

4.2. Either institution may terminate this agreement, with or without a cause by giving two (2) month proper written notice to the other.

4.3. A serious violation of this agreement by one party gives the other the right to terminate this agreement.

5. Other terms and conditions.

5.1. Separate agreement, annexes, alterations, additions are integral part of the Present Agreement and valid only in case if they are made in written form and signed by authorized representatives from the Parties.

5.2. This agreement is executed in two (2) counterparts of equal legal force, in English and Russian languages by authorized representatives of each institute; each Party will retain one counterpart of the Agreement.

6. Legal addresses and signatures of the Parties.
